1 AN ACT supplementing and amending the appropriations of public moneys out of the Treasury
2 from the balance of moneys remaining as an unappropriated surplus balance in the State
3 Fund, General Revenue, to the Department of Human Services, Bureau for Medical
4 Services – Policy and Programming, fund 0484, fiscal year 2025, organization 0511, by
5 adding a new item of appropriation for the fiscal year ending June 30, 2025.

1 WHEREAS, The Governor submitted the Executive Budget Document to the Legislature
2 on February 12, 2025, containing a statement of the State Fund, General Revenue, setting forth
3 therein the cash balance as of July 1, 2024, and further included the estimate of revenue for the
4 fiscal year 2025, less net appropriation balances forwarded and regular and surplus
5 appropriations for the fiscal year 2025, and further included recommended expirations to the
6 unappropriated surplus balance of the State Fund, General Revenue; and

7 WHEREAS, It appears from the Governor's Statement of the State Fund, General
8 Revenue, there now remains an unappropriated surplus balance in the Treasury which is
9 available for appropriation during the fiscal year ending June 30, 2025; therefore

Be it enacted by the Legislature of West Virginia:

1 That the total appropriation for the fiscal year ending June 30, 2025, to fund 0484, fiscal
2 year 2025, organization 0511, be supplemented and amended adding a new item of appropriation
3 as follows:


