1	AN ACT supplementing and amending the appropriations of public moneys out of the Treasury
2	from the balance of moneys remaining as an unappropriated balance in the State Fund,
3	State Excess Lottery Revenue Fund, by decreasing an existing item of appropriation to
4	the Economic Development Authority – Economic Development Project Fund, fund 9065,
5	fiscal year 2025, organization 0944, and increasing an existing item of appropriation to the
6	Department of Human Services, fund 5365, fiscal year 2025, organization 0511 for the
7	fiscal year ending June 30, 2025.
1	WHEREAS, The Governor submitted the Executive Budget Document to the Legislature
2	on February 12, 2025, containing a statement of the State Excess Lottery Revenue Fund, setting
3	forth therein the cash balance as of July 1, 2024, and further included the estimate of revenue for
4	the fiscal year 2025, less net appropriation balances forwarded and regular and surplus
5	appropriations for the fiscal year 2025; and
6	WHEREAS, It appears from the Governor's Statement of the State Excess Lottery
7	Revenue Fund, there now remains an unappropriated balance in the State Treasury which is
8	available for appropriation during the fiscal year ending June 30, 2025; therefore
