2	from the balance of moneys remaining as an unappropriated balance in the State Fund,

1	WHEREAS, The Governor submitted the Executive Budget Document to the Legislature
2	on February 12, 2025, containing a statement of the State Fund, General Revenue, setting forth
3	therein the cash balance as of July 1, 2024, and further included the estimate of revenue for the
4	fiscal year 2025, less net appropriation balances forwarded and regular and surplus
5	appropriations for the fiscal year 2025, and further included recommended expirations to the
3	unappropriated surplus balance of the State Fund, General Revenue; and
7	WHEREAS, It appears from the Governor's Statement of the State Fund, General
3	Revenue, there now remains an unappropriated balance in the Treasury which is available for
9	appropriation during the fiscal year ending June 30, 2025; therefore
	Be it enacted by the Legislature of West Virginia:

2	year 2025, organization 0506, be supplemented and amended by increasing an existing item of
