AN ACT making a supplementary appropriation of public moneys out of the Treasury from the balance of federal moneys remaining unappropriated for the fiscal year ending June 30, 2025, to the Department of Health, Office of the Inspector General, fund 8211, fiscal year 2025, organization 0513, by supplementing and amending the appropriations for the fiscal year ending June 30, 2025.

WHEREAS, The Governor has established the availability of federal funds for expenditure in the fiscal year ending June 30, 2025, which are hereby appropriated by the terms of this supplementary appropriation bill; therefore

Be it enacted by the Legislature of West Virginia:

That the total appropriation for the fiscal year ending June 30, 2025, to fund 8211, fiscal year 2025, organization 0513, be supplemented and amended by increasing existing items of appropriation and by adding new lines of appropriation as follows:






