1	AN ACT supplementing and amending appropriations of public moneys out of the Treasury in the
2	State Fund, General Revenue, by decreasing an existing item of appropriation to the
3	Department of Health Facilities, Health Facilities – Welch Community Hospital, fund 0412,
4	fiscal year 2025, organization 0512, and increasing an existing item of appropriation to the
5	Department of Health, Office of the Inspector General, fund 0437, fiscal year 2025,
6	organization 0513 by supplementing and amending appropriations for the fiscal year
7	ending June 30, 2025.
1	WHEREAS, The Governor submitted the Executive Budget Document to the Legislature
2	on February 12, 2025, containing a statement of the State Fund, General Revenue, setting forth
3	therein the cash balance as of July 1, 2024, and further included the revised estimate of revenue
4	for the fiscal year 2025, less net appropriation balances forwarded and regular and surplus
5	appropriations for the fiscal year 2025; and
6	WHEREAS, It appears from the Executive Budget document, Statement of the State Fund,
7	General Revenue, and this legislation, there remains an unappropriated balance in the State
8	Treasury which is available for appropriation during the fiscal year ending June 30, 2025;
9	therefore
	Be it enacted by the Legislature of West Virginia:
1	That the total appropriation for the fiscal year ending June 30, 2025, to fund 0412, fiscal
2	year 2023, organization 0512, be supplemented and amended by decreasing an existing item of
3	appropriation as follows:
