1 AN ACT to amend the Code of West Virginia, 1931, as amended, by adding a new article,
2 designated §1-8-1, relating to restrictions on powers of state agencies and political
3 subdivisions; prohibiting state agencies and political subdivisions from restricting use,
4 purchase, or sale of motor vehicles based on energy or power source; defining terms; and
5 providing exceptions.

Be it enacted by the Legislature of West Virginia:

**ARTICLE 8. RESTRICTIONS ON POWERS OF STATE AGENCIES AND POLITICAL
SUBDIVISIONS.**

§1-8-1. Restrictions of motor vehicles based on power source prohibited.

1 (a) No state agency or political subdivision of this state may restrict the use, purchase, or
2 sale of motor vehicles based on the energy source used to:

3 (1) Power the motor vehicle for propulsion; or

4 (2) Power other functions of the motor vehicle.

5 (b) For purposes of this section:

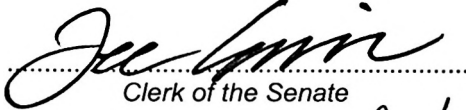
6 (1) "Motor vehicle" means a self-propelled device designed to transport persons or
7 property from one place to another and includes, but is not limited to, a "farm tractor" or "implement
8 of husbandry" as defined in §17A-1-1 of this code, but excludes "electric bicycles" as defined in
9 §17C-1-70 of this code;

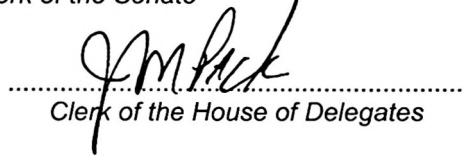
10 (2) "State agency" means any authority, board, department, instrumentality, institution,
11 agency, or other unit of state government; and

12 (3) "Use" refers to the use on a publicly maintained right-of-way that is open to the use of
13 the public for purposes of vehicular travel.

14 (c) This section does not affect or invalidate any rule or policy established by a state
15 agency or a political subdivision of this state related to the use, purchase, or sale of motor vehicles
16 by that state agency or political subdivision.

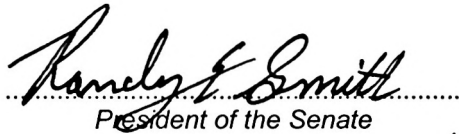
