1 AN ACT to amend and reenact §12-3-10e of the Code of West Virginia, 1931, as amended,
2 relating to modifying the Purchasing Card Advisory Committee membership to revise the
3 names of outdated titles for certain state entities and to reflect the consolidation of the
4 Information Services and Communications Division into the Office of Technology.

Be it enacted by the Legislature of West Virginia:

ARTICLE 3. APPROPRIATIONS, EXPENDITURES, AND DEDUCTIONS.

§12-3-10e. Purchasing Card Advisory Committee created; purpose; membership; expenses.

1 (a) There is created a Purchasing Card Advisory Committee to enhance the development
2 and implementation of the purchasing card program. The committee shall solicit input from state
3 agencies and make recommendations to improve the performance of the Purchasing Card
4 Program. The committee consists of 14 members to be appointed as follows:

5 (1) The Auditor shall serve as chairperson of the committee and shall appoint four
6 members from the Community and Technical College System of West Virginia and the system of
7 four-year higher education institutions, one member from the Department of Human Services,
8 one member from the Division of Highways, and two additional members at large from any state
9 agency;

10 (2) The Secretary of the Department of Administration shall appoint one member from the
11 I Office of Technology, one member from the Financial Accounting and Reporting Section, and
12 one member from the Purchasing Division;

13 (3) The Secretary of the Department of Revenue shall appoint one member from the
14 Department of Revenue; and

15 (4) The State Treasurer shall appoint one member from that office.

16 (b) Committee members shall be appointed for a term of one year, commencing on July
17 1. Committee members shall receive reimbursement for expenses actually incurred in the
18 performance of their duties on the committee.

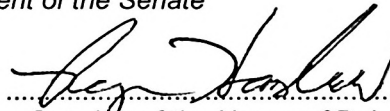

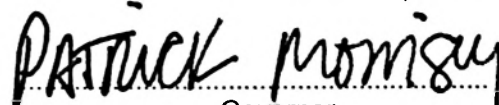
