1 AN ACT making a supplementary appropriation of federal funds out of the Treasury to the
2 Department of Human Services – Substance Abuse Prevention and Treatment, fund 8793,
3 fiscal year 2026, organization 0511, by decreasing and increasing the appropriations for
4 the fiscal year ending June 30, 2026.

1 WHEREAS, The Governor has established the availability of federal funds for expenditure
2 in the fiscal year ending June 30, 2026, which is hereby appropriated by the terms of this
3 supplementary appropriation bill; therefore
