1 AN ACT making a supplementary appropriation of public moneys out of the Treasury from the
2 balance of moneys remaining unappropriated for the fiscal year ending June 30, 2026, to
3 the Department of Health, Laboratory Services Fund, fund 5163, fiscal year 2026,
4 organization 0506, by supplementing and amending the appropriations for the fiscal year
5 ending June 30, 2026.

1 WHEREAS, The Governor has established that there now remains an unappropriated
2 balance in the Department of Health, Laboratory Services Fund, fund 5163, fiscal year 2026,
3 organization 0506, that is available for expenditure during the fiscal year ending June 30, 2026,
4 which is hereby appropriated by the terms of this supplementary appropriation bill; therefore

Be it enacted by the Legislature of West Virginia:

1 That the total appropriation for the fiscal year ending June 30, 2026, to fund 5163, fiscal
2 year 2026, organization 0506, be supplemented and amended by adding a new and increasing
3 existing items of appropriation as follows:

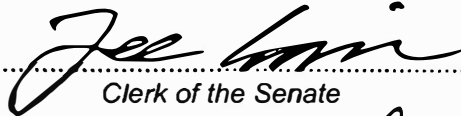

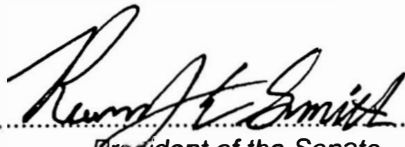
