1 AN ACT supplementing and amending the appropriations of public moneys out of the Treasury
2 from the balance of moneys remaining as an unappropriated balance in the State Fund,
3 General Revenue, to the Department of Human Services – Bureau for Social Services –
4 Office of the Commissioner, fund 0486, fiscal year 2026, organization 0511; to the
5 Department of Human Services – Bureau for Social Services – Child Protective Services
6 Case Workers, fund 0493, fiscal year 2026, organization 0511; to the Department of
7 Human Services – Bureau for Social Services – Social Services Case Workers, fund 0494,
8 fiscal year 2026, organization 0511; to the Department of Human Services – Bureau for
9 Social Services – Adult Protective Services Case Workers, fund 0495, fiscal year 2026,
10 organization 0511; and to the Department of Human Services – Bureau for Social Services
11 – Youth Service Case Workers, fund 0496, fiscal year 2026, organization 0511, by
12 increasing the appropriations for the fiscal year ending June 30, 2026.

1 WHEREAS, The Governor submitted the Executive Budget Document to the Legislature
2 on January 14, 2026, containing a statement of the State Fund, General Revenue, setting forth
3 therein the cash balance as of July 1, 2025, and further included the estimate of revenue for the
4 fiscal year 2026, less net appropriation balances forwarded and regular and surplus
5 appropriations for the fiscal year 2026, and further included recommended supplemental
6 appropriations from the balance of the State Fund, General Revenue; and

7 WHEREAS, It appears from the Governor's Statement of the State Fund, General
8 Revenue, there now remains an unappropriated balance in the Treasury which is available for
9 appropriation during the fiscal year ending June 30, 2026; therefore

Be it enacted by the Legislature of West Virginia:

1 That the total appropriation for the fiscal year ending June 30, 2026, to fund 0486, fiscal
2 year 2026, organization 0511, be supplemented and amended by increasing existing items of
3 appropriation as follows:

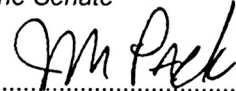

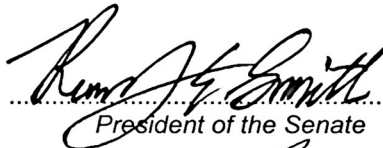

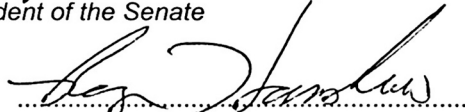
