1 AN ACT to amend the Code of West Virginia, 1931, as amended, by adding seven new sections,
2 designated §5-16-8b, §9-5-34, §33-15-4a, §33-16-20, §33-24-15, §33-25-23, and §33-
3 25A-37, relating to insurance; and providing definitions; and requiring health insurers to
4 provide coverage for scalp cooling systems for the preservation of hair during cancer
5 chemotherapy treatment.

Be it enacted by the Legislature of West Virginia:

**CHAPTER 5. GENERAL POWERS AND AUTHORITY OF THE
GOVERNOR, SECRETARY OF STATE AND ATTORNEY GENERAL;
BOARD OF PUBLIC WORKS; MISCELLANEOUS AGENCIES,
COMMISSIONS, OFFICES, PROGRAMS, ETC.**

ARTICLE 16. WEST VIRGINIA PUBLIC EMPLOYEES INSURANCE ACT.

§5-16-8b. Required coverage for scalp cooling system for cancer chemotherapy treatment.

1 (a) For the purpose of this section, "scalp cooling system" means any device used to cool
2 the human scalp to prevent or reduce hair loss during cancer chemotherapy treatment, provided
3 that such device is designed and intended for repeated use and is primarily and customarily used
4 to serve a medical purpose.

5 (b) Any insurer who delivers or issues a policy, plan, or contract that is issued or renewed
6 on or after January 1, 2027, under the provisions of this article and provides coverage for cancer
7 chemotherapy treatment shall provide coverage for scalp cooling systems used in connection with
8 cancer chemotherapy treatment as defined by the Centers for Medicare and Medicaid Services.
9 Coverage provided under this section may be subject to annual deductibles and coinsurance,

10 including copayments, as may be deemed appropriate by the commissioner and as are consistent

ARTICLE 5. MISCELLANEOUS PROVISIONS.

§9-5-34. Required coverage for scalp cooling system for cancer chemotherapy treatment.

2 the human scalp to prevent or reduce hair loss during cancer chemotherapy treatment, provided
3 that such device is designed and intended for repeated use and is primarily and customarily used
4 to serve a medical purpose.

5 (b) Any insurer who delivers or issues a policy, plan, or contract that is issued or renewed
6 on or after January 1, 2027, under the provisions of this article and provides coverage for cancer
7 chemotherapy treatment shall provide coverage for scalp cooling systems used in connection with

ARTICLE 15. ACCIDENT AND SICKNESS INSURANCE.

§33-15-4a. Required coverage for scalp cooling system for cancer chemotherapy treatment.

1 (a) This section shall be known and cited as "Jessica Huffman's Law".

2 (b) For the purpose of this section, "scalp cooling system" means any device used to cool
3 the human scalp to prevent or reduce hair loss during cancer chemotherapy treatment, provided
4 that such device is designed and intended for repeated use and is primarily and customarily used
5 to serve a medical purpose.

6 (c) Any insurer who delivers or issues a policy, plan, or contract that is issued or renewed
7 on or after January 1, 2027, under the provisions of this article and provides coverage for cancer
8 chemotherapy treatment shall provide coverage for scalp cooling systems used in connection with
9 cancer chemotherapy treatment as defined by the Centers for Medicare and Medicaid Services.
10 Coverage provided under this section may be subject to annual deductibles and coinsurance,
11 including copayments, as may be deemed appropriate by the commissioner and as are consistent
12 with those established for other benefits within a given policy.

§33-24-15. Required coverage for scalp cooling system for cancer chemotherapy treatment.

1 (a) For the purpose of this section, "scalp cooling system" means any device used to cool
2 the human scalp to prevent or reduce hair loss during cancer chemotherapy treatment, provided
3 that such device is designed and intended for repeated use and is primarily and customarily used
4 to serve a medical purpose.

5 (b) Any insurer who delivers or issues a policy, plan, or contract that is issued or renewed
6 on or after January 1, 2027, under the provisions of this article and provides coverage for cancer
7 chemotherapy treatment shall provide coverage for scalp cooling systems used in connection with
8 cancer chemotherapy treatment as defined by the Centers for Medicare and Medicaid Services.

6 on or after January 1, 2027, under the provisions of this article and provides coverage for cancer
7 chemotherapy treatment shall provide coverage for scalp cooling systems used in connection with
8 cancer chemotherapy treatment as defined by the Centers for Medicare and Medicaid Services.
9 Coverage provided under this section may be subject to annual deductibles and coinsurance,

10 including copayments, as may be deemed appropriate by the commissioner and as are consistent

ARTICLE 25A. HEALTH MAINTENANCE ORGANIZATION ACT.

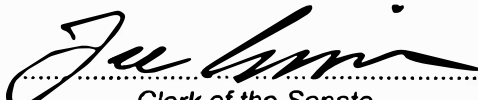
§33-25A-37. Required coverage for scalp cooling system for cancer chemotherapy treatment.

3 that such device is designed and intended for repeated use and is primarily and customarily used

6 on or after January 1, 2027, under the provisions of this article and provides coverage for cancer
7 chemotherapy treatment shall provide coverage for scalp cooling systems used in connection with

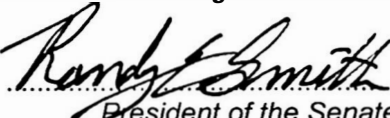
