1 AN ACT to amend and reenact §64-2-1 *et seq.* of the Code of West Virginia, 1931, as amended,
2 relating to authorizing certain agencies of the Department of Administration to promulgate
3 legislative rules; authorizing the rules as filed and as modified by the Legislative Rule-
4 Making Review Committee; authorizing the Department of Administration to promulgate a
5 legislative rule relating to the One-Stop Shop Permitting Program; authorizing the Office
6 of Technology to promulgate a legislative rule relating to cyber reporting; authorizing the
7 Board of Risk and Insurance Management to promulgate a legislative rule relating to mine
8 subsidence insurance; authorizing the Board of Risk and Insurance Management to
9 promulgate a legislative rule relating to the public entities insurance program; and
10 authorizing the Board of Risk and Insurance Management to promulgate a legislative rule
11 relating to Preferred Medical Liability and High Risk Medical Liability Program.

Be it enacted by the Legislature of West Virginia:

ARTICLE 2. AUTHORIZATION FOR DEPARTMENT OF ADMINISTRATION TO PROMULGATE LEGISLATIVE RULES.

§64-2-1. Department of Administration.

1 The legislative rule filed in the State Register on August 22, 2025, authorized under the
2 authority of §5A-13-6 of this code, modified by the Department of Administration to meet the
3 objections of the Legislative Rule-Making Review Committee and refiled in the State Register on
4 October 23, 2025, relating to the Department of Administration (One-Stop Shop Permitting
5 Program, 148 CSR 25), is authorized.

§64-2-2. Office of Technology.

1 The legislative rule filed in the State Register on July 18, 2025, authorized under the
2 authority of §5A-6B-3 of this code, modified by the Office of Technology to meet the objections of
3 the Legislative Rule-Making Review Committee and refiled in the State Register on August 14,
4 2025, relating to the Office of Technology (cyber reporting, 163 CSR 03), is authorized.

§64-2-3. Board of Risk and Insurance Management.

1 (a) The legislative rule filed in the State Register on July 18, 2025, authorized under the
2 authority of §33-30-15 of this code, modified by the Board of Risk and Insurance Management to
3 meet the objections of the Legislative Rule-Making Review Committee and refiled in the State
4 Register on August 14, 2025, relating to the Board of Risk and Insurance Management (mine
5 subsidence insurance, 115 CSR 01), is authorized.

6 (b) The legislative rule filed in the State Register on July 8, 2025, authorized under the
7 authority of §29-12-14 of this code, modified by the Board of Risk and Insurance Management to
8 meet the objections of the Legislative Rule-Making Review Committee and refiled in the State
9 Register on October 10, 2025, relating to the Board of Risk and Insurance Management (public
10 entities insurance program, 115 CSR 02), is authorized.

11 (c) The legislative rule filed in the State Register on July 21, 2025, authorized under the
12 authority of §29-12-5 of this code, relating to the Board of Risk and Insurance Management
13 (Preferred Medical Liability and High-Risk Medical Liability Program, 115 CSR 06), is authorized.

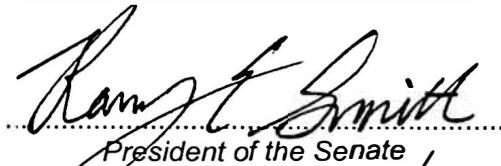
