1 AN ACT to amend and reenact §64-8-1 *et seq.* of the Code of West Virginia, 1931, as amended,
2 relating to authorizing certain agencies of the Department of Transportation to promulgate
3 legislative rules; authorizing the rules as filed and as modified by the Legislative Rule-
4 Making Review Committee; authorizing the Division of Motor Vehicles to promulgate a
5 legislative rule relating to motor vehicle equipment; authorizing the Division of Motor
6 Vehicles to promulgate a legislative rule relating to compulsory motor vehicle liability
7 insurance; and authorizing the Division of Motor Vehicles to promulgate a legislative rule
8 relating to special purpose vehicles.

Be it enacted by the Legislature of West Virginia:

**ARTICLE 8. AUTHORIZATION FOR DEPARTMENT OF TRANSPORTATION TO
PROMULGATE LEGISLATIVE RULES.**

§64-8-1. Division of Motor Vehicles.

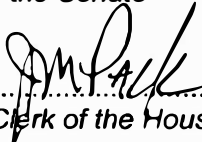
1 (a) The legislative rule filed in the State Register on July 24, 2025, authorized under the
2 authority of §17A-2-9 of this code, relating to the Division of Motor Vehicles (motor vehicle
3 equipment, 91 CSR 11), is authorized.

4 (b) The legislative rule filed in the State Register on July 24, 2025, authorized under the
5 authority of §17A-2A-8 of this code, modified by the Division of Motor Vehicles to meet the
6 objections of the Legislative Rule-Making Review Committee and refiled in the State Register on
7 September 22, 2025, relating to the Division of Motor Vehicles (compulsory motor vehicle liability
8 insurance, 91 CSR 13), is authorized.

9 (c) The legislative rule filed in the State Register on June 23, 2025, authorized under the
10 authority of §17A-13-1 of this code, relating to the Division of Motor Vehicles (special purpose
11 vehicles, 91 CSR 25), is authorized.

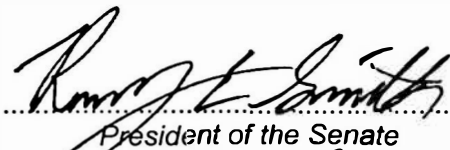
