1 AN ACT to amend and reenact §7-7-1 and §7-7-4 of the Code of West Virginia, 1931, as
2 amended, relating to providing increased salaries for county commissioners, sheriffs,
3 county clerks, circuit clerks, county assessors and prosecuting attorneys; making
4 legislative findings; eliminating requirement for the Auditor to certify that the fiscal
5 condition of the county has sufficiently improved over the previous fiscal years so that
6 there exists an amount sufficient for payment of the increase in salaries and related
7 employment taxes; and eliminating requirement that who desire to receive increased
8 salary must prior to effective date of salary increase have filed in the office of clerk of the
9 county commission his or her written request for the salary increase.

Be it enacted by the Legislature of West Virginia:

ARTICLE 7. COMPENSATION OF ELECTED COUNTY OFFICIALS.

§7-7-1. Legislative findings and purpose.

1 (a) The Legislature finds that it has, since January 1, 2023, consistently and annually
2 imposed upon the county commissioners, sheriffs, county and circuit clerks, assessors, and
3 prosecuting attorneys in each county new and additional duties by the enactment of new
4 provisions and amendments to this code. The new and additional duties imposed upon the
5 aforesaid county officials by these enactments are such that they would justify the increases in
6 compensation as provided in §7-7-4 of this code, without violating the provisions of W. Va. Const.
7 Art. VI, §38.

8 (b) The Legislature further finds that there are, from time to time, additional duties imposed
9 upon all county officials through the acts of the Congress of the United States and that such acts
10 constitute new and additional duties for county officials and, as such, justify the increases in
11 compensation as provided by §7-7-4 of this code, without violating the provisions of W. Va. Const.
12 Art. VI, §38.

13 (c) The Legislature further finds that there is a direct correlation between the total
14 assessed property valuations of a county on which the salary levels of the county commissioners,

15 sheriffs, county and circuit clerks, assessors, and prosecuting attorneys are based, and the new
16 and additional duties that each of these officials is required to perform as they serve the best
17 interests of their respective counties. Inasmuch as the reappraisal of the property valuations in
18 each county has now been accomplished, the Legislature finds that a change in classification of
19 counties by virtue of increased property valuations will occur on an infrequent basis. However, it
20 is the further finding of the Legislature that when such change in classification of counties does
21 occur, that new and additional programs, economic developments, requirements of public safety
22 and the need for new services provided by county officials all increase, that the same constitute
23 new and additional duties for county officials as their respective counties reach greater heights of
24 economic development, as exemplified by the substantial increases in property valuations and,
25 as such, justify the increases in compensation provided in §7-7-4 of this code, without violating
26 the provisions of W. Va. Const. Art. VI, §38.

27 (d) The Legislature further finds and declares that the amendments enacted to this article
28 are intended to modify the provisions of this article so as to cause the same to be in full compliance
29 with the provisions of the Constitution of West Virginia and to be in full compliance with the
30 decisions of the Supreme Court of Appeals of West Virginia.

**§7-7-4. Compensation of elected county officials and county commissioners for each class
of county; effective date.**

1 (1) The increased salaries to be paid to the county commissioners and the other elected
2 county officials described in this section on and after July 1, 2014, on and after July 1, 2022, and
3 on and after July 1, 2026, are set out in subsections (2) and (4) of this section. Every county
4 commissioner and elected county official in each county, whose term of office commenced prior
5 to or on or after July 1, 2014, shall receive the same annual salary by virtue of legislative findings
6 of extra duties as set forth in §7-7-1 of this code.

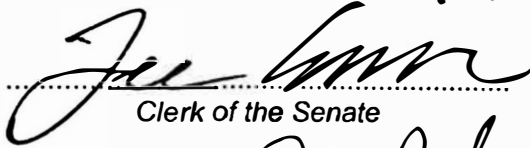

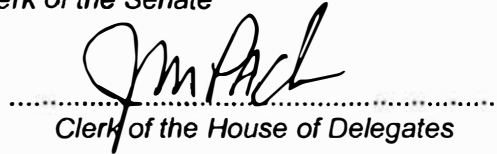

67 (5) Any county clerk, circuit clerk, county assessor, prosecuting attorney, or sheriff of a
68 Class I through Class V county, inclusive, any assessor or any sheriff of a Class VI through Class
69 IX county, inclusive, shall devote full time to his or her public duties to the exclusion of any other
70 employment: *Provided*, That any public official whose term of office begins when his or her
71 county's classification imposes no restriction on his or her outside activities may not be restricted
72 on his or her outside activities during the remainder of the term for which he or she is elected.
