Be it enacted by the Legislature of West Virginia:

**ARTICLE 12. WEST VIRGINIA SUPREME COURT OF APPEALS PUBLIC CAMPAIGN
FINANCING PILOT PROGRAM.**

**§3-12-1. Termination of the West Virginia Supreme Court of Appeals Public Campaign
Financing Program.**

1 The West Virginia Supreme Court of Appeals Campaign Financing Pilot Program
2 established pursuant to this article will terminate on June 30, 2026: *Provided*, That on or after July
3 1, 2026, any unexpended balance remaining in the Supreme Court of Appeals Public Campaign
4 Financing Fund shall be transferred to the General Revenue Fund.

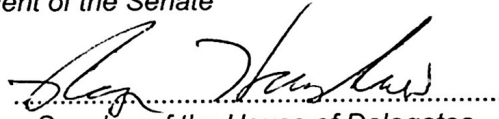

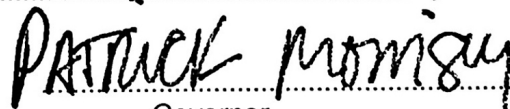
